### FAMILY CRISIS INTERVENTION UNIT – Harbor House

This is the Family Crisis Intervention Unit out of Court under the guidelines set forth in N.J.S.A. 2A:4A-76 et seq. and the Juvenile/Family Crisis Operations Manual by the New Jersey Judiciary. Program provides services or a referral to all callers. Staff provides in-person screening, as well as short-term crisis counseling. The goal of this program is to stabilize juvenile family crisis and prevent these youth from entering Family Court. Heidi Hartman is FCIU Director.

### FAMILY COURT DIVERSION PROGRAMS – Youth Advocate Programs, Inc. (YAP)

This program provides 2 hour Anger Management, Bullying and Shoplifting workshops quarterly to youth in Ocean County. Program workshops are geared towards first time offenders. This program also provides a 9 week Anger Management Program for youth needing more than a 2 hour workshop. Workshops can be used as a Stationhouse Adjustment for SRO's and Juvenile Officers. Additional workshops are hosted as needed: Sexting, etc.

### SUBSTANCE ABUSE EVALUATION & OUTPATIENT TREATMENT PROGRAM -

Ocean Mental Health Services

This program provides the Family Court with a clinical substance abuse assessment and counseling service. Assessments, including a urine test, are done at the behest of the Family Court. Recommendations are reported to the Family Court or Juvenile Supervision. Assessments of detained youth are done at the Detention Center within 2 days of referral.

Also, Level 1 and Level 2 substance abuse education and counseling is provided to juveniles with substance issues as a dispositional option to the Court or as a Re-entry option.

**PROBATION ENRICHMENT PROGRAM ("PEP")**- is a post-dispositional program that is funded by the Youth Services Commission. Services are provided by Ocean County Juvenile Probation Supervision. The program offers three (3) components. The first component will offer selected probationers over the course of twelve (12) months with a five (5) week structured program focusing on cognitive skills, team building, decision making and problem solving skills. The second component will offer, within forty-five (45) days of sentencing, an individual orientation presentation for the parents of youth placed on probation. The third component will offer all juveniles and their families various current educational presentations on a quarterly basis in Lakewood and Toms River.
